Information about the Personal Data Administrator.

Information about the Data Protection Officer.

Information about the recipients of personal data.

Your personal data may be disclosed to the following categories of recipients:

- a) authorized employees and associates of J.S. Hamilton Poland Sp. z o. o.,
- b) Entities cooperating with the administrator in the organization of conferences.
- c) Companies providing IT services and other services supporting the organization of conferences.
- d) Public authorities and other entities authorized under the law.

Information about the purposes and legal bases for the processing of personal data:

Your personal data as conference participants are processed for the purpose of:

- a) Registration and service of participation in the conference.
- b) Sending information about the conference and post-conference materials.
- c) Fulfillment of obligations resulting from the provisions of law.
- d) Documentation of the conference, including the publication of photos and video materials. organization and coordination of the conference "THE TRUTH IN PACKAGING LETS TALK ABOUT FACTS".

Legal basis for the processing of personal data:

- a) Article 6(1)(b) of the GDPR data processing is necessary for the performance of a contract to which the data subject is a party.
- b) Article 6(1)(c) of the GDPR data processing is necessary to comply with a legal obligation to which the controller is subject.
- c) Article 6(1)(f) of the GDPR data processing is necessary for the purposes of the legitimate interests pursued by the controller, such as direct marketing.

Information about the period of personal data processing.

Personal data will be stored for the period necessary to achieve the purposes of processing, but no longer than until the statute of limitations for claims under the contract expires.

Information about the obligation to provide data.

Providing personal data is voluntary, but necessary to participate in the conference. Failure to provide data will prevent participation.

Information about the rights of data subjects.

The data subject may exercise the following rights against the controller:

- a) request access to their personal data and to rectify them (Article 15 and Article 16 of the GDPR),
- b) request the restriction of the processing of their data in the situations and on the terms set out in Article 18 of the GDPR or to delete them in accordance with Article 17 of the GDPR ("right to be forgotten"),
- c) withdraw consent at any time without giving reasons and without affecting the lawfulness of the processing that was carried out on the basis of consent before its withdrawal
- d) lodge a complaint with the supervisory authority the President of the Data Protection Office (2 Stawki Street, Warsaw). In the remaining scope, due to the failure to meet the conditions set out in the provisions of the GDPR, the rights will not be implemented.

Information about automated data processing, including profiling.

Your personal data will not be used for automated decision-making, including profiling.

Information on transfer outside the European Economic Area.

Your personal data will not be transferred to third countries, i.e. outside the European Economic Area.
